#### Section 3. Hazards Identification

Routes of Entry: Inhalation. Skin contact (absorption). Eye contact. Ingestion.

**Potential Acute Health Effects** 

Eyes: Liquid or spray mist may severely irritate eyes. Inflammation of the eye is characterized by redness,

watering, and itching.

Skin: This product may irritate skin upon contact. Harmful if absorbed through the skin. Skin inflammation is



## Section 7. Handling and Storage

#### **Precautions**

Keep locked up and out of reach of children. Manipulate in a well ventilated area. In case of insufficient ventilation, wear suitable respiratory equipment. Do not breathe gas/fumes/vapor/spray. Avoid contact with skin and eyes. Contact lenses should not be worn when working with chemicals because they may contribute to the severity of an eye injury. Keep away from foodstuff, drinks and tobacco. Eating, drinking and smoking should be prohibited in area where this material is handled, stored and processed. #### Storage
